Election Notice

Nominations

A person may nominate for more than one Group but can only be elected to one Group. The order of seniority is as listed below.

Nominations are invited on and from Monday 10 February 2020 for:

2 Directors (Group 2) 3 year term

1 Director (Group 1) 2 year term - vacancy

1 Director (Group 3) 1 year term - vacancy

Only Life Members and Club Members, Perpetual Members and Senior Members who have been financial members of the Club for at least three (3) consecutive years are to nominate for and be elected to hold office on the Board.

Nominations must be made by two (2) Life Members or Club Members or Perpetual Members or Senior Members (other than the candidate) who have been financial members of the Club for at least three (3) consecutive years. No eligible member shall nominate more candidates than the number to be elected.

Lodgement of Nominations

Nomination Forms must be received by the Returning Officer, NSW Electoral Commission (**NOT THE CLUB**) no later than **12.00 noon, Monday 24 February 2020**. A nomination can only be withdrawn by a written, signed statement received by the Returning Officer prior to the close of nomination. Any anomaly in the Nomination Form must be rectified before the close nominations.

Candidate Profile Forms

Candidates can submit a Candidate Profile Form including a passport size photograph of themselves to the Returning Officer. The Candidate Profile Form must be received by the Returning Officer by no later **12.00 noon, Monday 2 March 2020**. Any alteration or addition to a Candidate Profile Form must be rectified by 12.00 noon, Monday 2 March 2020. Information supplied in the Candidate Profile Forms will be displayed in the voting area and the Club's website prior to the commencement of voting and during voting.
